**Registration and Weekly Fees**

The YMCA Summer Day Camp is for Campers entering 1<sup>st</sup> – 8<sup>th</sup> grade in the fall. There is a one-time registration fee of \$30 (unless paid when child was in Kid’s Club school year- prior year). This fee is due with the registration form and will reserve a spot for your camper. It is a non-refundable fee and does not apply to any other costs. This allows you to reserve a spot for each week your camper plans to attend YMCA Summer Day Camp program. Please pay the weekly fees on or before the Friday of services rendered. Please indicate on the check which week(s) you are paying for. **Your child will not be allowed to attend camp if you more the one week behind.** The weekly fee covers field trips but does not include swim lessons. **If you desire for your child to attend swim lessons during session 1, our staff will walk them to lessons and remain with them. Campers will receive lessons at members cost of \$32 paid prior to lessons beginning.**

**Y Summer Day Camp Sunscreen Permission Form**

YMCA day camp participants spend a great deal of time in the outdoors and at the pool, thereby exposed to the sun's harmful rays. Since it is our commitment to promote healthy spirits, minds and bodies, we have made the following policies in this regard:

- We recommend that your camper have sunscreen applied in the morning before coming to camp.
- Each camper will be responsible for his/her own bottle of sunscreen with an SPF of at least 30 in their swim bags with their name in permanent marker.
- Day camp staff will be responsible for applying sunscreen after lunch, prior to swimming and again at the 2:45 break. We will apply sunscreen at other times per request.
- We encourage each child to allow a staff person to apply the sunscreen to ensure proper coverage, however, per parent request, we will allow older campers to apply their own sunscreen.

I verify that I have read the above information. I give permission for the YMCA Day Camp staff to apply sunscreen to my child and understand that the first application of sunscreen is my responsibility prior to sending my child/children to camp. It is also my responsibility to make sure my child has sunscreen with them daily.

## CAMP YALE WAIVER AND RELEASE OF LIABILITY

I HEREBY ACKNOWLEDGE AND AGREE the facilities of CAMP YALE, including, but not limited to, its ponds, campgrounds, hiking trails, cabins, picnic facilities, climbing tower and ropes course, have INHERENT RISKS. I have full knowledge of the nature and extent of the INHERENT RISKS associated with outdoor climbing and ropes course facilities, including but not limited to:

1. Injuries that might result from improper use of, or falling from the climbing tower or ropes course.
2. Rope abrasion, entanglement and other injuries resulting from activities on the ropes course.
3. The importance of helping to spot others and proper lookout for other climbers or participants on the ropes course.
4. Cuts and abrasions resulting from skin contact with the climbing tower or ropes course.
5. Failure of ropes, slings, bolts, cables, climbing hardware, anchor points, or any part of the climbing tower structure or ropes course.

I further acknowledge the above list is not inclusive of all possible risk associated with the use of CAMP YALE's facilities, its climbing tower or ropes course, and the above list in no way limits the extent or reach of this Waiver and Release of Liability. I agree as follows:

To waive and release any and all claims I have or may have in the future against CAMP YALE including, but not limited to, its owners, operators, employees, agents and representatives, as well as the designers, manufacturers or installers of the climbing tower or ropes course equipment for personal injury or property damage resulting from the use of their facilities, climbing tower or ropes course unless caused by the gross negligence of said individuals or entities. In the event a claim is brought against CAMP YALE by me or on my behalf that is covered by this Waiver and Release of Liability, I agree to be responsible for reasonable attorney fees and costs incurred by CAMP YALE with respect to said claims.

I agree to use CAMP YALE's facilities, climbing tower and/or ropes course in accordance with its established safety policies and procedures and agree to INDEMNIFY AND HOLD HARMLESS CAMP YALE its owners, operators, employees, agents and representatives, as well as the designers, manufacturers or installers of the climbing tower or ropes course equipment from any and all causes of action, claims, demands, losses or costs of any nature whatsoever arising out of or in any way relating to my use of CAMP YALE's facilities, climbing tower or ropes course, whether asserted by CAMP YALE or any third parties who may be injured on account of or in any way relating to CAMP YALE.

This agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and assignees in event of my death. If any provision of this waiver and release shall be held invalid, void or illegal, that provision shall in no way affect, impair or invalidate any of the other provisions and such other provisions shall remain in force and effect.

I certify I am at least eighteen (18) years of age and legally competent to sign this agreement. I certify I am in good health and I have no physical limitations, which would preclude my use of CAMP YALE's facilities, climbing tower or ropes course. I understand the terms of this Waiver and Release of Liability are legally binding. I have read this Waiver and Release of Liability carefully and am signing it of my own free will.
